# Nevada Commission on OHV

## **Overview and Grant Program Update**

## 2011 through March 1, 2017

### **Commissioner Sue Baker and Jenny Scanland, Executive Secretary**

The Nevada Off-Highway Vehicle Commission was established by NRS effective July 1, 2011 to promote the responsible use of recreational off-highway vehicles pursuant to NRS 490. The Commission has granting authority for OHV registration fee proceeds, with grants given in accordance with approved regulations. Grants are currently provided for law enforcement, education/public awareness and OHV trail management and development. The Commission on Off-Highway Vehicles is currently made up of 11 voting members appointed by the Governor and nine non-voting members.

#### January/Feb. 2017 – New Commissioners appointed by Governor.

## Condensed History of the Commission on Off-Highway Vehicles

June 2011 - Law establishing Commission.

**Feb. 2012** - First Commission meeting. The next year of meetings was busy with determining size, color and placement of registration sticker; how the Commission would function; hiring of the executive secretary and job duties; general grant processes.

July 2012 - Program to register and title OHV's went into effect.

July 2013 - 85% of the first year's revenue went to DMV for their set up.

Fall 2013 - First round of grants pursued.

Jan 2014 - Grants attempted to be awarded.

- Potential lawsuit exposed lack of formal grant regulations to defend award decisions.
- The Commission was directed to cancel all grants.
- The Commission attempted to create the regulations and guidelines on their own, and eventually it was suggested they reach out and work with the Nevada Office of Grant Procurement, Coordination and Management. Through a very long process, including support from the office of Deputy Attorney General, they were successful in developing the required regulations.

**June, 2014 Audit -** At direction of Executive Branch Audit Committee – an audit of the OHV Program was conducted beginning June, 2014.

March 2015 - Final draft regulations sent to the Legislative Counsel Bureau with formal adoption of regulations by OHV Commission - June 15<sup>th.</sup>

June 2015 - Law Enforcement grants awarded.

Law Enforcement grants were funded based on recommendations from the Office of Criminal Justice: There was a total of \$186,205 in law enforcement awards round with funds allocated towards salaries and overtime, as well as equipment. All of these grants are closed except for Humboldt who requested an extension through September, 2017. Completion rate of 88%.

**June 9, 2015** - Senate Bill 492 passed and was approved by the Governor. The Department of Motor Vehicles now covers its expenses and transfers to the Commission all program revenues in excess of \$150,000 on a quarterly basis. This began in July 2015 and is proceeding as directed. It was anticipated at that time that the account revenue would be \$750,000 per year at current registration rates.

August 2015 - Legislative Committee approved granting regulations.

**September - October 2015 -** Commission released Request for Proposal. \$700,000 was made available to award grants under two categories: education/outreach, and trails. Trails include studies such as environmental, economic, or usage studies, new trail construction, rehabilitation, facilities, signage, etc. There was a noted lack of *eligible* project applications.

# Early 2016, the Commission in partnership with the State Grants Office released an RFP for Grants with due date of June 24, 2016 with estimated \$600,000 available.

*Audit Update - At direction of the Nevada State Executive Branch Audit Committee – an audit of the OHV Program was conducted beginning June, 2014. This audit closed summer of 2016. This audit resulted in the Governor placing the Commission on OHV's under the Department of Conservation and Natural Resources (DCNR).* 

**May 2016** - The Nevada Commission on Off-Highway Vehicles was placed within the DCNR. This was done in part through an Interim Finance Committee action that created an executive budget for the OHV Commission within the Department of Conservation and Natural Resources fiscal structure.

**June 20, 2016** - DCNR hired a part-time classified staff person to manage the OHV grant program and act as executive secretary to the board.

- An analysis of the granting process and active outreach to applicants is occurring as the new staff member (executive secretary) within the Department of Conservation and Natural Resources assumes the program.
- The goal is to increase the number of eligible applications for consideration and aggressively award funds.
- Staff has developed a grant tracking and reporting process which is based on a previous tracking and reporting system that has met with audit approval.

June 24, 2016 - Grant Application Due Date. Applications processed by DCNR executive secretary and brought to commission for scoring and vote on October 6.

July 15, 2016 - Executive secretary completed the audit response. Audit closed.

#### July/August, 2016 DCNR

- Pending law enforcement grant awards completed.
- Legislative Report Competed.
- An FY 18-19 Executive Budget for Budget Account 4285 was prepared by the DCNR Director's Office and is being considered by legislative committee as part of the 2017 Session of the Nevada Legislature. This will be the first time the proposed use of Commission funds will be considered both by the Executive and Legislative branches during a regular session.
- The DCNR Director's Office prepared a Bill Draft Request that is now Assembly Bill 29 that complements the budget approach outlined in the Department's budget submittal.

Friends of NV Wilderness S. Most of the labor to execute the projects will be completed by volunteers and include the South McCullough Wilderness, which needs the most attention, Brownstone Basin in the Red Rock Canyon NCA and Arrow Canyon in the Arrow Canyon Wilderness. Volunteers will: install kiosks with interpretive and Tread Lightly information to ensure that riders are aware they are nearing a non-motorized recreation area. Affected routes will be naturalized to disguise and discourage use. Some sites may need barriers at wilderness boundaries. Outreach will occur with Tread Lightly vehicle.

**October 6, 2016** – Trails, Outreach and Education Grants Commission Decision. Grant agreements awarded and <u>all in progress</u>, no reimbursements to date.

**December 13, 2016** – Commission Meeting. Last meeting for all Commissioners. All positions expiring Jan 1, 2017. Commissioners were briefed on DCNR processes and paperwork with the state of Nevada completed. Updates on budget, grant program and AB29 were presented.
