- ▶ Training and installation of signs in progress.

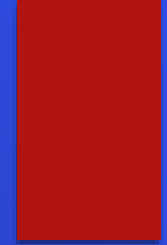

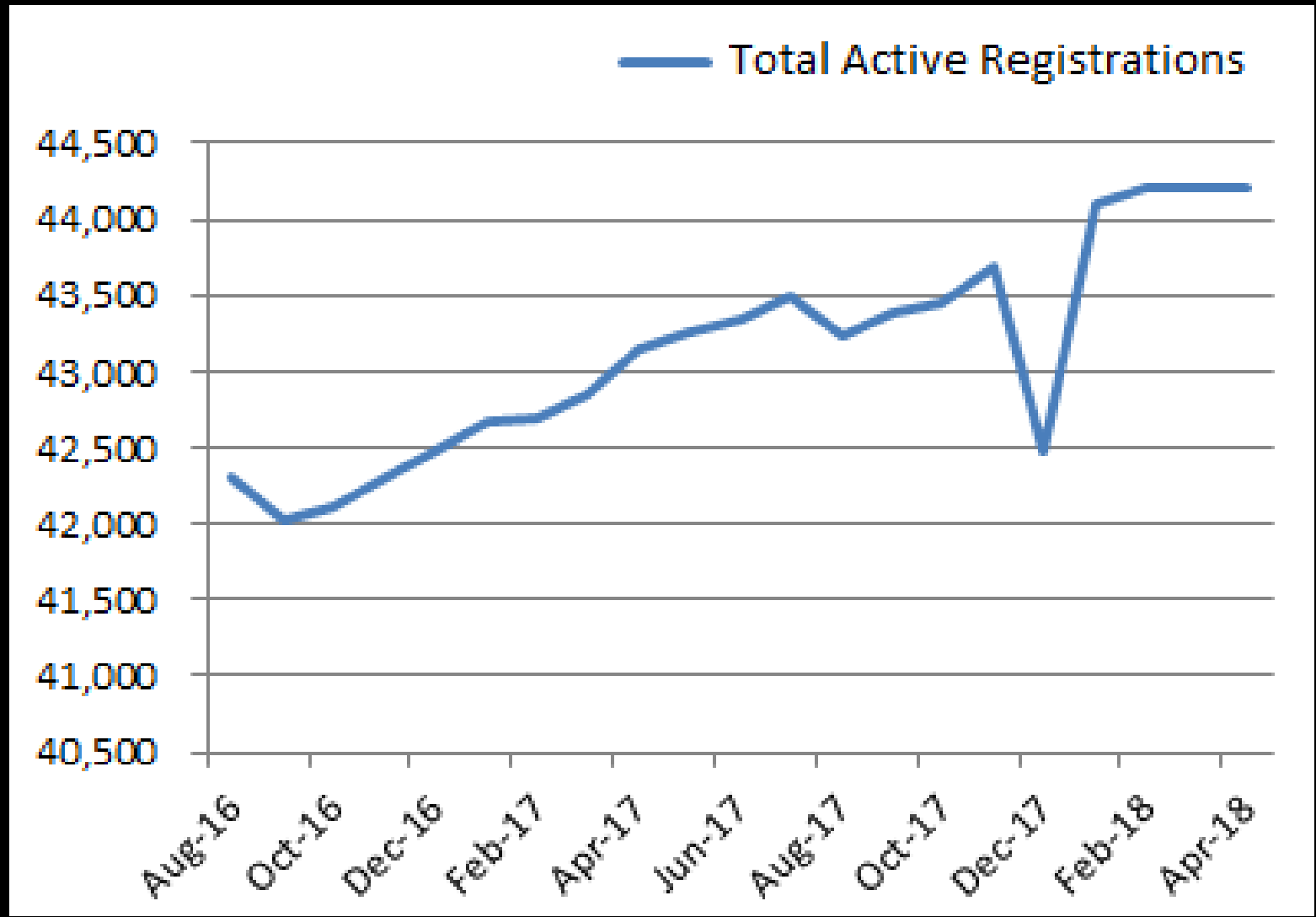

INOHVAA - WESTERN STATES

INTERNATIONAL OFF-HIGHWAY VEHICLE ADMINISTRATORS ASSOCIATION

- CO - **Requires by law all dealers to sell a registration at the point of sale for all vehicles sold.**
- CO - **Out of state sticker** is souvenir worthy, anyone can purchase at vendors.
- NM - **Out of state stickers (no reciprocity)**
- AZ – **New law - Out of state stickers (no reciprocity)**
- WY - **ALL off-road vehicles display a Wyoming permit (no reciprocity)**
- ID – **WY must purchase ID sticker, others reciprocity**
- **All having problems with lack of enforcement.**

3. Require reg. with sale of vehicle.

AB29 Survey

- ▶ **The Statute Presumption and Other Questions**
- ▶ **Commission comments back to Staff by end of June.**
- ▶ **The survey process**
 - ▶ **DCNR/Commission Official request: does the NRS need amending?**
 - ▶ Municipalities, Federal, State, LE/PD (also include survey questions)
 - ▶ **Other survey questions**
 - ▶ Website embedding and Facebook messaging (415+) DCNR (4000)
 - ▶ Listserv OHVNEWS (592+)
 - ▶ All current and past grantees from OHV and RTP 100+
 - ▶ Manually entering survey (Team in field)
 - ▶ **Team gathers and compiles for 3 months July - Sept**
 - ▶ **Team prepare report**
 - ▶ **Staff report with recommendation to Commission - vote not later than December 11 meeting.**
 - ▶ **Recommendation to LCB before end of year.**
