Our education and volunteer recovery services we offer to the public increase user safety and confidence when going off-road. Our social media presence is strong with over 7K local vetted follows on our FB page. Our community outreach ahs made off-roading safer and has grown the interest and participation in the use of OHV vehicles and the supported trails.

2. Enhancement or Maintenance of existing trails and facilities: How will maintenance needs be prioritized and how often will your project hold a maintenance/ trails enhancement event? HOW will your project be maintained and WHO has committed to the ongoing maintenance of the facility or trail (note: a minimum of 2 maintenance/ trail events are required per year).

Our SNORR group holds regular trail clean-up days where we get out and volunteer our time in partnership with other off road local enthusiast groups to clean up trash in the more popular destinations. Lake mead, Nelson's landing, Mt Charleston, Mt Potosi, are a few areas we have and conducted clean up events in the past and will continue to do.

**3. Training:** Please describe the goals and objectives of your public safety training program. Is it a nationally recognized certification? What sets your safety training program apart from the others?

We plan on hosting a total of 20 in person hands-on off-road safety and recovery classes for the public in 2022-2023, These classes are 3hrs long and accommodate up to 30 people per class. The classes go into detail on how off road safely, gear and supplies to bring, how to use a variety of recovery equipment components such as a winch, recovery straps, traction boards, etc. We also go into detail about MBS and WLL in regard to safety and weight limits when using recovery equipment. Also, includes Tread lightly techniques to preserve the OHV trails during use. Additionally, we serve the public by volunteering to rescue stranded off road vehicles when a tow truck can not reach them, and owners need assistance getting their vehicles back to paved roads.

Part of our tier member certification to become a volunteer with SNORR is to be certified with Treat Lightly. We ensure our volunteers follow these principles taught in this course and we communicate the lessons from this to the students on our classes and to the local community we engage with regularly.

SNORR not only is means to educate the public on the safety of off-road use but we also volunteer our time 365 days a year to rescue the public when they are broken down, stuck, or their vehicle is disabled while off road. We close the gap on what tow trucks are willing to do on road vs what an

off-road vehicle will need to be repaired or towed back to a safe location for towing. We DO NOT charge for our services and work strictly on donations as a 501c organization. As of 10/1 we have safety recovered and have tracking of over 650 stuck vehicles needing assistance in fiscal 2021 alone.

**8.** Partnering and Leverage: Who else is involved in this project? Please describe outreach with stakeholders, partners and local governments, that you have communicated with in planning this project.

We have partnered with local law enforcement including NHP, US National Park Service -Lake Mead, LV Metro Police, and US Forest Service and do so on a regular basis. They know to contact us when they have an off-road vehicle that needs assistance, and they cannot get help from an on road tow service. We most recently received an award from NHP for our service to the public in Mt Charleston area during the winter months with disabled vehicles in the snow. I will attach the award and letters from these partners with this application.


**9. Economic Integration:** How will this project improve OHV recreation opportunities that help local, regional, or state economies grow?

SNORR helps to solve for the problem of dealing with stuck, disabled, broken down off-road vehicles by recovering them back to pavement and by assisting stuck vehicle owners that are also at rick of the weather and elements which at times can be life threatening situations. We provide support to NPS, NHP, Metro, and other law enforcement and rescue agencies. We provide safety and recovery classes to the public which are not offered elsewhere. By keeping the public safe, providing a solution to off road enthusiasts that need help, and volunteering our time and services to the public we feel strongly that this will grow OHV usage and in turn grow the economy through OHV vehicle sales, recovery equipment sales, and registration of OHV.



When not being used at the classes, we can use the equipment while volunteering our time conducting rescues of disabled vehicles on the trails of southern Nevada to service the public and aid in assisting our local law enforcement agencies as mentioned above.
