CITY OF ELKO Off-Highway VEHCILE PROGRAM SCOPE OF WORK

In order for the City of Elko to become an Off-Highway Vehicle friendly community, the City of Elko is planning an Off-Highway Vehicle Program within the City Limits. The goal of the program is to increase access into and out of the city for Off-Highway Vehicles. The City project is focusing on planning the OHV program, development of maps and signage, safety training and education, and compliance/enforcement. In order to meet this goal the Off-Highway Vehicle (OHV) workgroup has developed the following objectives, measurements, and timelines.

OBJECTIVES, MEASUREMENT, & TIMELINES

1. Develop a City ordinance/code outlining OHV use in the City of Elko. The ordinance will include ingress/egress access points, safety requirements, and environmental and outdoor ethic requirements. To be appointed and organized by February 1, 2019. Measured by passage of ordinance by City Council.

- Request City Council appoint the Off-Highway Vehicle (OHV) Workgroup as an advisory group to oversee/manage the City of Elko OHV program. Completed by end of February 2019.
- 3. Order and install signs to be placed at each ingress/egress access point. Signs may include spots to place brochures and maps. City Public Works Department to install and maintain signs. To be completed by December 2019.
- 4. Develop a public awareness/outreach campaign for Off-Highway vehicle use within the City Limits. Develop and print maps outlining ingress/egress points, disseminate maps to various places throughout the City to include local hotels, Chamber of Commerce, Elko Convention and Visitors Authority, social media, Elko Daily Free Press, public events, etc. Maps to be completed by December 2019.
- 5. Develop brochures outlining the rules, regulations and procedures of the ordinance. Include environmental and outdoor ethic requirements with focus on water and habitat conservation. Print and disseminate the brochure throughout the City of Elko. Schedule radio ads and appearance segments. Officers will be provided brochures to hand out while on patrol. Brochures will be distributed by end of December 2019.
- 6. OHV Advisory Council to schedule meeting with the BLM, Forest Service, State officials, County officials, private land owners and City officials to begin process of collaboration with Silver State Trails begin development of "agreements" with the City. This process to begin by January 2019 and agreements in place within one year.
- 7. Implement Law Enforcement Strategies to include the following:
 - A. Up to two officers will become certified trainers in the Outdoor Schools Rider Classes. They will teach three courses per year with one course geared toward persons under age 21. Measured by the number of people trained. To be completed within one year.
 - B. Hold two classes for law enforcement personnel to learn the Off Road Vehicle ordinance rules, regulations and police department policy. Will be measured by the number of officers/staff in attendance. To be completed by June 2019.
 - C. Elko Police Department will hold an annual vehicle identification (VIN) and Registration check event. The event will feature the maps, brochures, vendors, and other informational items regarding the City Off-Highway Vehicle Program. First event to be held by December 2019.
 - D. Elko Police Department will enforce the City Off-Highway vehicle ordinance. The City will purchase an Off-Highway vehicle and trailer. The City will outfit the vehicle with police markings, police lighting package and radio system. The vehicle/trailer will be stored and maintained by the Elko Police Department Fleet Services unit. The Elko Police Department will patrol the ingress/egress access points on weekends, holidays, and special events. This will begin within one year and be measured by police contacts and completion of a field interview cards, warnings, or citations.

The goal of the City of Elko Off-Highway Vehicle (OHV) Program is to increase access to off road vehicles within the city limits, making Elko an OHV friendly community, by developing and implementing an OHV ordinance and program within the city limits. In order to reach this goal there are several objectives, one of which is developing the law enforcement strategy. The following objectives address this:

- 1) Educate law enforcement personnel of the OHV ordinance by holding a minimum of two classes annually for law enforcement officials regarding the OHV ordinance rules, regulations, and enforcement policies.
- 2) Outreach and education for the public regarding personal safety and environmental safety procedures. Up to two law enforcement officials will become a certified instructors and participate in three rider classes per year on OHV safety (one class specific to youth under age 21).
- 3) Elko Police Department will hold an annual Vehicle Identification (VIN) and Registration Public Education Event annually in the spring. The event will include the new OHV code, maps, brochures, safety rules and other information. The event will include advertising in the media, social media and radio ads in order to get participation. The event will be measured by the number of people attending the event and the number of vehicles registered and inspected.
- 4) Elko Police Department will enforce the OHV code rules and regulations by patrolling the ingress/egress access areas during weekends, holidays and City events. This will include the purchase of an off road vehicle, purchase of safety equipment, and purchase of a transport trailer. The vehicle will be used not only for enforcement activities, but may also be used as a means for public education regarding the City of Elko OHV Code and Program during parades and other City events. The vehicle will include signage regarding the City of Elko OHV Program. This objective will be measured by tracking the number of law enforcement contacts and field interview cards completed by officers.
- 2. Trail mapping, signing and maintenance of existing trails and facilities: Please describe how your project/program assists in the maintenance and/or rehabilitation of Existing Facilities. "Taking care of what is already there to protect the investment."

The goal of the City of Elko Off-Highway Vehicle (OHV) Program is to make a Elko an OHV friendly community by developing and implementing a City ordinance on Off-Highway Vehicle use within the City of Elko. As a starting point, the City of Elko is looking at assigning five to six ingress/egress access points throughout the City in

which OHV's can enter or leave the City. The code must be easily understood by the public and preserve the environment as it is currently. The objectives to reaching this goal include:

- 1) Determine the best ingress/egress access points by holding public meetings and workshops to develop the ordinance.
- 2) Partner with other agencies (BLM, Forest Service, Nevada Department of Transportation, Elko County, private land owners, and Bureau of Indian Affairs) to assist in a survey of existing facilities and develop agreements with the City as well as trail mapping.
- 3) Develop easy to understand maps of the ingress/egress access points and make them readily available to the public through outreach events, social media, and other media. This will include signs at each point, maps available and brochures.
- 3. Training: Please describe the goals and objectives of your public training program, i.e., Public Education, Rider Classes, Safety, Trail Building, or Outdoor Ethics. Number of people trained, contacts made, etc.

Another objective of the City of Elko Off-Highway Vehicle (OHV) Program is to develop a public awareness/outreach campaign for OHV use in the city of Elko. This includes the following steps:

- 1) Up to two Elko Police Department officers will be certified as trainers for Rider's Classes as stated above. They will teach a minimum of three classes per year (one geared to persons under age 21). This will be measured by the number of classes held and the number of students in attendance.
- 2) Elko Police Department will have a Vehicle Identification (VIN) and Registration event with public outreach and safety education one time per year as stated above. This will be measured by the number of VIN and registration checks completed at the event and the number of people in attendance at the event.
- 3) Once the ordinance is passed the City will develop, print, and disseminate maps of the ingress/egress access points. Maps will be disseminated at specific OHV events, as well as other public events. Maps will be available at local hotels, the Chamber of Commerce, the Elko Visitors and Convention Center, the local OHV dealerships, and various other public places.
- 4) Once the ordinance is passed the City will develop, print, and disseminate brochures that outline the ordinance rules, regulations, and safety procedures.
- 5) Once the ordinance is passed the City will run newspaper and radio ads regarding the rules/regulations and public events regarding the City of Elko OHV program.
- 6) The City of Elko OHV workgroup will collaborate with the Silver State Trails to coordinate GPS mapping and develop agreements/contracts.
- 4. Law Enforcement, SAR with NO Registration component: How will your officer training, equipment purchase or salary/overtime request serve the off-highway vehicle recreating public?

The public will be served by public education and outreach efforts. Law enforcements officers patrolling during weekends and holidays will be trained in the rules, regulations, and safety procedures. They will make contact with the public in an effort to first educate them. Officers will have the maps, the brochures, and other information available during patrol. These contacts will be measured by the number of field interview cards completed by patrol officers. As stated previously, the City will have a registration event.

5. Access: Please describe how your project/program ensures protection of access. Explain what access/opportunities would be lost or restricted if the project doesn't occur.

The City of Elko Off-Highway Vehicle (OHV) program is based on the concept of access. The City is in the process of developing an ordinance that will include 4-5 points of access into or out of the City on an off road vehicle. The ordinance requires public input, as well as collaboration with other State, County, and Federal officials. It is essential the ordinance includes public outreach, training, safety and law enforcement in order to ensure the public understands the rules, regulations, and safety procedures, as well as to limit any damage to the environment. This grant funding will ensure the public training and law enforcement aspect of this ordinance. Without this funding training and law enforcements ability to enforce the ordinance will be limited and restricted.

6. Economic Integration: Please describe how your project/program develops outdoor recreation opportunities that help local, regional, or state economies grow (e.g., economic impact, additional OHV funding sources, improved user or business group participation, Road use resolutions and OHV friendly Communities.)

The County of Elko has recently passed an Off-Highway Vehicle (OHV) Ordinance. Currently, those living within the City limits must trailer their (OHV) and drive out of City limits in order to do any recreation. Developing an ordinance and allowing access points within the city will potentially increase tourism in Elko. Collaborating with the Silver State Trails and adding Elko to the GPS mapping could bring potential tourists that will eat at local restaurants, stay in hotels, buy gas, and shop in local stores. This could also increase the number of OHV sales in the community, as well as increase the number of OHV registrations in the State.

7. Connectivity/Loops: Please describe the increase in connectivity between trails, facilities and other locations that your project/program would provide or enhance when completed. Attach maps if necessary, i.e., towns, parks, areas, trails, etc.

The City of Elko is surrounded by County, State, and Federal and private land. Elko is the largest incorporated area in a 225 mile radius. The City lies along the historic California Trail and currently houses the California Trail Interpretive Center. The City also straddles the Humboldt River. There are several Off-Highway vehicle and four wheel drive vehicle trails surrounding Elko. The City of Elko Off-Highway

Vehicle Program (OHV) goal is to increase access to OHV trails and recreation by passing a City ordinance allowing ingress and egress access points from the City to surrounding trail areas. Obtaining this grant funding is essential to building the collaboration needed to work with the Silver State Trails as well as other State and Federal programs and private land owners in order to ensure safe, ethical, and environmentally friendly access to current trails and recreation areas. The City will work to secure agreements with surrounding land owners in an effort to increase and maintain connectivity from the access points to the trails.

8. Planning, Environmental Studies, Conservation: please describe how the environmental studies and/or planning will result in maintaining or expanding OHV riding areas. Describe HOW your project/program considers water and habitat conservation.

The City of Elko Off-Highway Vehicle Program (OHV) is in the planning and development stage. The program includes four objectives.

- 1) The first objective is to write and pass a City ordinance allowing access points within the City limits to off road vehicles. The access points will not be located next to the Humboldt River or any habitat conservation areas.
- 2) The second objective is to provide public outreach, training and education regarding the ordinance rules, regulations and safety procedures. The public outreach and education trainings will not only focus on safety but on environmental protection, outdoor ethics and respect of wildlife.
- 3) The third objective is develop the law enforcement approach. Law enforcement will include public demonstrations in outdoor ethics and safety, as well as patrol of the OHV access points. The program will track the number and type of officer contacts using field interview cards in order to establish any patterns or issues that may need further clarification in training or further regulation in an additional ordinance.
- 4) The final objective is to determine future expansion needs and efforts regarding OHV trails and facilities. This will be done through collaboration and development of agreements/contracts across County, State, Federal, and private land owners of off Road Vehicle and trail programs.

As stated above, water and habitat conservation is a priority for the City and is addressed in each objective. It will be a key point in the ordinance as well as in enforcement efforts.

9. Partnering and Leverage: Please describe coordination that has occurred with stakeholders, partners and the public in which all interests have had an opportunity to be heard related directly to this project/program. Also, describe how your project/program leverages private, BLM, USFS, State, local government, or in-kind funding, services or donations (Considered as investment in the project. The City of Elko is in the beginning stages of the off road vehicle program planning and development. The Elko City Council approved the development of a workgroup that includes City staff as well as interested public members to discuss the possibility of an ordinance allowing OHV access within City limits. This workgroup developed the goal of making Elko an OHV friendly community by increasing OHV access in the City limits along with all the objectives stated in the scope of work. If this grant is received the City will propose to City Council that this workgroup become an official Advisory Committee for the City OHV program and be subject to open meeting law.

One of the objectives for the workgroup is to begin collaborating with private land owners, the State, Federal entities as well as the County. At this point in the planning process the in-kind services are being leveraged by the City, however it is expected that as the work continues, the City will develop memorandums of understanding and agreements with other entities regarding in kind services and the City of Elko OHV program. The following is a list of City in kind services as outlined in the budget:

- City of Elko will provide oversight and administration to the work group to meet the objectives as outlined.
- City staff will write the ordinance specified on the work group instructions. It will be reviewed and approved by the City attorney prior to being presented to Council.
- City staff will oversee and manage the OHV workgroup. City staff will record the minutes of the work group and do any other administrative duties related to the OHV program.
- City staff will draw the necessary maps using City purchased equipment and supplies. City staff will disseminate the maps.
- City staff will order, install and maintain signs at each ingress/egress access point.
