1 - Provide hands-on industry recognized off-road driving and recovery training of offroad vehicles (UTVs – ATVs – SxSs – plated OHVs) to 775 OFR volunteers and the general public. This includes safe recovery practices, proper selection - and use - of recovery gear and tools, as well as practicable self-recovery techniques. Classes to the general public also include a section specifically related to safe, sound, responsible and legal trail riding practices, utilizing Tread Lightly's extensive Quick Tips for UTV, ROV and SxS, thus minimizing the impact on our recreational trails

(treadlightly.org/learn/recreation-tips/utvohving). In addition, we will discuss, and provide copies of, 'Your Guide to Off-Highway Vehicles in Nevada' brochures at all general public training and outreach events. Information therein includes, but is not limited to, proper use of protective gear, discouraging impaired driving and excessive speeding, and encouraging timely and legal registration of vehicles. 775 OFR will also leverage resources found on OHV Nevada's website (ohv.nv.gov/resources#education), specifically playcleango, and others as may be appropriate.

2 - Send two 775 OFR instructors to the International 4WD Trainer's Association for internationally recognized off-road driving and recovery certification, providing them knowledge to develop a more comprehensive training curriculum for both 775 OFR volunteers and General public trainees, because 'Being an expert does not mean one is an educator." 3 – Equipment is the single largest expense our organization incurs. When winches, winch cables, tow ropes, shackles, recovery traction boards, tree savers, etc. break or become worn out, they cannot be repaired. Currently, 775 OFR member's personal equipment is being utilized for general public training and a large number of the trainees don't possess the required recovery equipment, or the equipment they do bring to classes does not meet the rigorous industry standards to which 775 OFR adheres.  Law Enforcement Strategy that addresses registration enforcement, including Public Education & Outreach aimed at increasing renewals and new registrations: During general public classes, and the organization's functions and programs, we will promote and emphasize the importance of current registration of all OHVs. We will also promote the importance of registering OHVs on 775ofr.com and our Facebook page. Training will also include other safety and responsibility tips as discussed in "Your Guide to Off-Road Highway Vehicles in Nevada" brochure.

2. Enhancement or Maintenance of existing trails and facilities:

At the direction of Public Lands Management, abandoned vehicles can be safely removed by properly trained teams. In providing resources to assist disabled OHV owners recovery of their vehicles in a timely manner, it also reduces additional abandonment of vehicles on the trails system. This is a proactive, rather than reactive approach to trail maintenance and enhancement.

3. Training:

Providing properly trained personnel, with the appropriate equipment to remove disabled abandoned vehicles, OHVs, or plated vehicles adds significant value to the OHV community. Partnering with the OHV community (Desert Pigs, Nevada Four Wheel Drive Association, etc.) creates an additional resource. The training allows for a standard process and skill-set for vehicle recoveries. Failure to deploy and follow appropriate retrieval protocols adds unnecessary damage to Nevada's OHV trails. Additionally, focusing on the negative environmental impacts stranded and abandoned vehicles represent during the training, and advocating Tread Lightly's principles, are integral components of our training curriculum.

As mentioned earlier in the Scope, 775 OFR will proactively offer hands-on driver training in hopes people will not need 775 OFR's services.

6. Planning, Environmental Studies, Conservation:

Removing disabled OHVs and plated vehicles mitigates the danger they pose to curious people and local wildlife. When disabled vehicles are abandoned, they pose significant environmental hazards including - but not limited to - leaking fluids, disintegrating and dispersal of loose vehicle parts and assemblies (ie., tires, broken glass, mechanical assemblies, etc.). All training classes emphasizes the need and importance of 'reclaiming the trail' in accordance to Tread Lightly's protocols.

8. Partnering and Leverage:

775 OFFROAD and RECOVERY coordinates with multiple Local, State and Federal agencies for the services they currently provide. When 775 OFR reaches out to BLM, USFS, or BIA, the organization is usually recognized (when not recognized, it is most often due to us not having conducted a recovery in their particular jurisdiction area, but these instances are becoming rarer as we conduct more recoveries and our reputation grows). Increasingly, Law Enforcement Agencies are referring stranded off-roaders to 775 OFR for recovery services. Towing companies throughout our operation area also refer stranded individuals to 775 OFR because they often don't have the resources, or equipment, to reach the areas where OHVs typically become disabled.

9. Economic Integration:

In partnership with Public Lands Management, recovery of disabled OHVs and plated vehicles provides a positive off-road experience. The sooner disabled vehicles are removed, potential environmental hazards are mitigated and Public Lands agency's personnel are freed up from spending time dealing with situations they very often don't have the training, tools and/or resources to properly deal with. In summary, travelers in Nevada and Nevada residents have the properly trained volunteers of 775 OFR as a safety net should their OHV become disabled. No one wants a stranded person to become a person in need of rescue – causing a financial burden that greatly impacts local, and often State law enforcement resources.

I was asked to write a letter to share my experience with 775 Offroad and Recovery. I am a retired CMSgt from the Air Force and was in charge of the survival section conducting all of the Aircrew's combat, water and desert survival training to include many SAR training and operations. I am currently a reservist with the NV State Department of Emergency Management and worked in operations over the past year for the states COVID-19 response and also during the Caldor fire. I joined 775 Offroad and Recovery earlier this year and have completed all my course and hands on training to be certified as a Level 3 recovery support responder.

It is my understanding they have applied for a grant to pay for a training program to improve the qualifications of their leaders and to provide a training program to its members and the public. The service they already provide is unvaluable. There have been many occasions where individuals have stuck, trapped or disabled vehicles in hard to reach places across northern Nevada. In many cases, towing companies won't assist because of these hard to reach areas. For example a couple of months ago I responded to a vehicle that would not start in a deep ravine miles out in the Pine Nut Mountains which too 3 recovery vehicles and hours to get the truck and his two dogs out to the main road.

It is important for this organization to continue to grow and receive advanced training. In turn, they can improve their current training program for it's members and anyone else who wants to learn. This organization provides amazing training and additional training would only enhance its capability to respond and recover our fellow Nevadans and anyone else who may become stranded on our lands.
