Mr. Narkhede,

Lincoln Resource Group Corp. manages 7 square miles of land and mineral rights comprising both private and U.S. Forest Service (USFS) land surrounding the Pine Grove Canyon area south of Yerington. Included within our land package is the Pine Grove Cemetery on USFS land where Lincoln holds the mineral rights.

Lincoln has reviewed the proposal for the cemetery access barrier. Damage has occurred in the past when the public has accessed the cemetery area with off road vehicles. The cemetery area is not clearly marked and is an irregular shape. Installing a wooden fence as described will help to mitigate further damage to the gravesites. The proposed fuels reduction is also warranted due to recent infestation of lps beetles the pinions are dying and are extreme fire hazards. Care needs to be taken removing the trees and brush due to the potential spreading of the beetles to other areas.

Lincoln has an approved cultural resource investigation plan with the USFS which includes research and field work at the cemetery. Canine Forensics will be utilized to determine if there are additional graves beyond the known cemetery area. This work may be completed in December 2021 weather permitting. The proposed fence would be a good first step for managing access to the site. Over the long term (plus two years) Lincoln hopes to gain the approval to install a more permanent reinforced stone fence around the cemetery. A mitigation plan for the long-term protection of the area would be part of Lincolns EIS work including stakeholder involvement. This proposed fence is needed now to stop ongoing damage to the cemetery. It would also act as a permanent long-term barrier to manage the overall site access. 



Scope of Work

NVFCP will complete the application for section 106 review with the Nevada State Historic Preservation Office (NVSHPO) for the installation of a temporary buck and rail fence/barrier and interpretive sign to block vehicular access to the cemetery in the Pine Grove Mining District (26LY361). This application and its associated documentation, such as maps and photographs, will be provided to the Archaeologist for the Bridgeport Ranger District. The archaeologist must approve the application and submit it to the NVSHPO.

If the Bridgeport Ranger District agrees to the barrier being in place for no longer than 5 years, NVFCP anticipates being able to justify the finding of no adverse effect to historic properties. However, one in person site visit is required to ensure the area of potential effect is properly described and to gather photographs to justify that determination.

If the NVFCP prepared application requires edits, those will be provided as soon as possible. This estimate provides for a maximum of three revisions.
