A focus for this grant will be to field a four-person snow ranger crew that will patrol popular winter recreation areas to monitor public safety and educate the public on OHV regulations, Nevada OHV registration requirements, as well as serve as points of contact for the public to voice any concerns with user conflict, safety, etc. User conflict will be managed by having the crew on the ground and available to support the public.

Great Basin Institute, in cooperation with the US Forest Service Humboldt-Toiyabe National Forest Ruby Mountains, Santa Rosa, and Ely Ranger Districts, is requesting funding to enhance winter OHV recreational opportunities and the safety of winter OHV enthusiasts by continuing the winter recreation snow ranger program. The program, established in 2020 with funding provided by the Nevada Off-Highway Vehicle Commission and continued in 2022 with funding from the State of Nevada Recreational Trails Program, will field four technicians in 2023, for a total of thirteen weeks. The technicians will conduct snowmobile patrols in specific winter recreation areas throughout the identified ranger districts, including Lamoille Canyon, Secret Pass, Harrison Pass, Ward Mtn, Success Summit, USFS lands surrounding Cave Lake State Park, Hinkey Summit, and Granite Peak. Day-to-day activities will include backcountry snowmobile patrol, avalanche safety education & response, Nevada OHV registration education & outreach, wilderness boundary signing, and maintenance of existing facilities including grooming trails, clearing snow from parking areas, and cleaning restroom facilities.

In addition, we are requesting grant funds to purchase winter recreation safety equipment for each team member, including helmets and goggles, winter clothing, and accessories (i.e. pants, jacket, gloves, and boots). Equipment purchased by the grant will be stored, managed, and maintained by the US Forest Service and used for subsequent field seasons. If available, equipment from prior years will be used and budgeted funds can be returned to NVOHV or potentially utilized for additional project needs.

Our project will incorporate Public Education and Outreach aimed at increasing renewals and new registrations by having our four-person snow ranger crew patrolling popular winter sport recreation areas across three counties and educating the public on Nevada's OHV registration program, including what classifies an OHV, who is required to register, registration fees, registration process, and general information on Nevada's OHV program, including how registration fees are utilized to enhance OHV recreation in NV. With an increased understanding of the program and how the registration fees enhance OHV recreation around the state, the public will be more likely to renew registration or initiate a new registration.

- 2. Enhancement or Maintenance of existing trails and facilities:** *How will maintenance needs be prioritized and how often will your project hold a maintenance/ trails enhancement event? The scope of work outlined in this project directly contributes to the maintenance of existing outdoor infrastructure by removing snow to maintain access to roads and parking lots used for winter recreation access, cleaning restroom facilities used by the public throughout winter recreation season, and grooming trails used by all user groups to access winter recreation areas.

The objectives of our project's public education component are to educate the public on avalanche safety and Tread Lightly tips for responsible winter recreation (i.e. travel responsibly, respect the rights of others, educate yourself, avoid sensitive areas, and do your part). The goals of our project's public education component will be to increase the public's awareness and knowledge of our primary education objectives, as well as improve public safety and increase responsible winter recreation.

- 4. Trail mapping and signing of existing trails and facilities:** *If a mapping component is included in the grant, please describe how it will be integrated with the current web mapping application found on OHV.NV.GOV*

Under the State of Nevada Recreational Trails Program grant, the winter ranger program successfully mapped winter recreation areas and staging areas for the Ruby Mountain, Santa Rosa, and Ely Ranger Districts during the 2021 field season. The team will continue to track winter recreation use and collaborate with the US Forest Service and GBI Nevada Mapping Collaborative to provide the public with the most up to date and current mapping data available.

The USFS Humboldt-Toiyabe winter recreation areas were created to continue providing the public access to many of the scenic and natural resources found throughout the national forest even during winter months when access is typically limited. Improving access to and safe use of the system of trails will improve the user's ability to continue navigating to these scenic and natural resources.

Although this project will not result in direct protection of access to recreation sites, the four-person snow ranger team will be responsible for maintaining access for popular winter recreation sites by clearing snow from parking areas.

This project is in partnership with the US Forest Service Humboldt-Toiyabe National Forest Ruby Mtn, Santa Rosa, and Ely Ranger Districts, Great Basin Institute's Research Associate service program, Ruby Mountains Helicopter Ski operation, and Nevada State Parks Recreational Trails Program.

It is important to note that in addition to the two project vehicles that will be provided by the US Forest Service, they will also supply fuel for the project vehicles and snowmobiles, trailers used for transporting snowmobiles, grooming equipment for maintaining trail access, radios and In-Reach safety devices for field use, and housing for technicians living in Elko

and Ely. The team will also use one snowplow purchased using RTP grant funds, as well as one USFS owned snowmobile and one UTV equipped with tracks for snow travel.

This project focuses on improving public safety and providing safe opportunities for winter recreation. In doing so, this project will continue to enhance OHV recreational opportunities for the region and provide the foundation for attracting visitors to the area. The additional visitation to the region will have a direct impact to economic growth through tourism dollars.

Having a USFS presence in the District brings a higher level of public safety and education, especially in the heavily recreated areas.














