Attached is the grant proposal for the Kokopelli ATV Club in Mesquite, Nevada from January 2018 to January 2020. The Kokopelli ATV Club, along with its partnering OHV Clubs, intends to assemble and place 650 road/trail marking signs in southeastern Lincoln County, Nevada to mark road/trails between Mesquite, Nevada and Caliente, Nevada. This will provide connectivity from Mesquite to Caliente and to the Silver State Trails system. Additionally, we plan on placing approximately 10 safety signs at key entrances to backcountry lands warning recreational users to carry proper supplies and equipment for their vehicles and themselves.

As a follow-up to this grant we intend to indefinitely continue our partnership with the BLM in maintaining these signs. We also intend to apply for additional grants to: develop maps for this area, provide maintenance for the installed signs, provide minor maintenance for the roads and trails, continue trash pickup, and install additional trail marking and informative signs identifying landmarks, sensitive environmental habitat, and historical areas. Our continued goal will be to provide connectivity to recreational opportunities in state parks, national monuments and wilderness areas, and other trails to the west, east, and north of the trails we already marked.

The primary purpose of this project is to identify and mark intersections along two key routes (approximately 90 miles each) and any connecting loops in southern Lincoln County from Mesquite to Caliente, Nevada with 650 Carsonite-type signs. A total of approximately 200-300 miles of roads and trails are to be marked. This signage will also provide connecting routes between Mesquite, Nevada and Caliente, Nevada with the Silver State Trail System.

In preparing this grant application, the Kokopelli ATV Club personnel identified and mapped the GPS coordinates of intersections on key routes between Mesquite, Nevada and Caliente, Nevada, and the Silver State Trails System using Garmin Base Camp. This information was shared with the

BLM Caliente office which then gave us their go-ahead with a Categorical Exclusion (CX) to place signs at the intersections on County/BLM lands. This Categorical Exclusion will allow us to place additional trail and road marking signage with the BLM's approval and without the requirement for further NEPA or other studies.

We also intend to place ten Informational Safety Signs near the entrances of key travel routes to warn travelers of potential dangers (e.g., dehydration, exposure to extreme cold or heat) and suggest equipment and supplies vital to their safety and survival. On these signposts we will post Tread Lightly and/or Pack It In & Pack It Out signs as well. Additionally, we will place BLM signs marking sensitive eco-zones and habitat in areas identified by the BLM. *All signs* will be marked with lettering or stickers stating this is "Your Nevada OHV Dollars at Work".

As we travel the routes, we will pick up trash, identify and communicate any road/trail hazards to the appropriate maintenance personnel in Lincoln County or the BLM. With their permission, we will address minor hazards such as boulders, trees, and minor erosion problems in the roads/trails.

Purchased equipment (OHV trailer and accessories, motorized hammer (REDI Driver) and accessories for driving Carsonite signs), tools and supplies will be kept in a rental storage area (Mayan) in Mesquite or in Club Officers'/Trail Bosses' garages in Mesquite.

The work will be completed between January 2018 and January 2020. It is our intent to complete this work as soon as possible though it is impossible to delineate an exact schedule since it will require multiple trips, using volunteer labor, over two years, in a large geographic area. The timing of volunteer availability will be one scheduling consideration. Weather conditions will also limit work in the high-altitudes near Caliente, Nevada in winter months or lower altitudes near Mesquite, Nevada in the summer months.

Following completion of this project, it is our intent to: continuously maintain the signage we installed, identify other areas where road/trail marking and informational signage are needed in Lincoln and Clark Counties, seek funds to install more signs with greater connectivity to other cities and parks, and develop maps of these routes for public use.

Section VII Scoring Narrative

1. Public Education, Law Enforcement and Outreach: Please describe how your project/program will incorporate public education and/or outreach to increase registration and showcase the benefit of OHV communities, including registration events.

Public safety is the primary emphasis of this project. First, we want to assure that travelers into remote areas have the proper equipment and supplies for their survival should they or their vehicles become incapacitated. Second, we want them to know where they are at all times to minimize their chances of getting lost and venturing off-road and across country. Marking intersections along their way with road and trail numbers and ultimately creating maps for public use should greatly reduce this possibility.

The kiosk-type signs will be installed at key entrances to remote areas of public lands to warn/educate users of potential dangers (dehydration, exposure to extreme temperatures, etc.) and suggest equipment and supplies useful for their safety, such as a GPS, spare vehicle tires, significant amounts of water, layers of clothing etc.

All 650+ signs will have the Nevada OHV logo on them which will emphasize "Your Nevada OHV Dollars at Work!" Additionally, all signs will have an American flag on them which should decrease vandalism.

The Dunes and Trails ATV Club from Las Vegas and the Partners in Conservation of Logandale have committed to supporting this grant and assisting Kokopelli ATV Club in the installation of these signs. One example of educational benefits is the interest of the FFA teacher for Mesquite High School in having her students work on this as an FFA project. We believe that getting young people involved in this project (which also includes trash pickup) will help future generations learn natural resource stewardship and the importance of protecting the environment.

Lincoln County Search and Rescue (SAR) will be significantly helped by better trail identification to help locate people in need of assistance more quickly.

2. Trail mapping: Please describe how your project will move public lands in Nevada towards having travel plans completed and will result in trail mapping and creation of maps for the public.

Currently, the southern part of Lincoln County has no signs marking its county roads or BLM trails. This makes it very dangerous for anyone but locals to venture out in this vast area because they could easily get lost. Mapping for this area will be followed up with additional grant requests after roads and trails have been properly marked.

Kokopelli ATV Club has GPS'ed the coordinates of the key intersections on routes between Mesquite and Caliente, Nevada and the Silver State trails. The majority of Lincoln County trails are in the BLM Travel Management system with numbers assigned; however, some of the existing trails must still be entered into the system before numbers can be assigned for identification purposes on the signs. We will coordinate with the BLM and set priorities for signage installation based on routes already in the Travel Management system and as more are added to the system. Leveraging the GPS work by Kokopelli ATV Club, we will also lobby for the early addition of more identified routes into the system.

3. **Access:** Please describe how your project ensures protection of access. Explain what access/opportunities would be lost or restricted.

Continued and improved access for everyone to enjoy and appreciate these natural resource environments is the number one goal for the Kokopelli ATV Club. It is our intent by marking the roads and trails in this vast area to encourage greater recreational use for all, not just OHV.

Safety/informational signs and road and trail markers are anticipated to reduce the possibility for people to become lost and encourage more of the general public to enjoy this great natural resource. The signs should also keep more people on the marked roads and trails and help reduce off-roading in sensitive areas. This should help mitigate some of the concerns of environmentalists.

It is the Kokopelli ATV Club's intent to remove garbage/trash from the marked routes during the project. Additionally, we will be providing minor maintenance on some of the roads and trails and/or notifying BLM in Lincoln County of hazardous conditions.

Expanded use and the economic development brought to the communities of Mesquite and Caliente will reinforce the value of assured access. Without these improvements to address identified needs, access might needlessly be restricted in the future.

4. **Demand for new facilities: Please describe the justification (the demand)** for new facility development: restrooms, trails, signs, and other amenities.

While installing trail signs is the primary emphasis of this grant, the mayor of the City of Mesquite has identified the possible availability of one new safe staging area where people could park their vehicles and OHV trailers when traveling southern Lincoln County trails.

5. **Connectivity:** Please describe the increase in connectivity between trails, facilities, and other locations that your project/program would provide when completed. Attach maps if necessary.

This project would improve connectivity across 85 to 90 miles of open country between Mesquite and Caliente, Nevada. It would also provide connection to the Silver State Trail System and the Kershaw Ryan State Park. There are numerous mines in this area such as the Delamar Mine and its associated ghost town which would be connected to the roads and trails to be marked. These sites should eventually have informational kiosks explaining their historical significance that could be developed with future OHV grants.

6. **Environmental Studies:** Please describe how your environmental studies, project/program is in a highly desired area that will result in maintaining or expanding OHV riding areas.

The environmental study for this grant project has already been completed by the BLM office and the favorable results formed the basis for granting a Categorical Exclusion (CX) so that we can place signs on roads and trails throughout Lincoln County without additional studies being done. This is a great aid to the OHV community and will expand OHV use of these trails. Many of the trails that have been used for years in this vast area have never formally been identified and brought into the BLM system. Identifying and marking them will make them part of the OHV system for future generations.

7. **Design for Conservation:** Please describe how your project/program considers water and habitat conservation. Example: how the trail features are designed to be sustainable while protecting environmentally sensitive areas or important wildlife habitat area.

As part of our partnership with the BLM office in Caliente, they will provide us with signs such as "Tread Lightly", "Pack It In and Pack It Out", "Sensitive Habitat Areas -- Stay on Roads/Trails" that we intend to add to our warning signposts at the entrances to key areas. We will also place sensitive habitat signs wherever the BLM would like us to in the areas we are working. This will include stickers on the Carsonite signs we will be placing at intersections in sensitive habitat area for the desert tortoise. Keeping people on the marked roads and trails will help reduce off-roading in sensitive areas.

The BLM will also be providing training for the Kokopelli ATV Club's key personnel (Trail Bosses) about the desert tortoise and its habitat.

8. **Existing Facilities:** Please describe how your project assists in the maintenance and/or rehabilitation of **existing** facilities. "Taking care of what is already there to protect the investment."

The Kokopelli ATV Club feels very strongly about protecting our public lands. As we travel these areas to place signs, we will pick up trash found and/or notify the BLM or the County of significant trash dumps. We also will take high school students with us so they can learn and appreciate what it means to be good stewards of the land.

9. **Leveraged Projects:** Please describe how your project leverages private, BLM, USFS, state, local government or in-kind funding, services or donations (considered as investment in the project).

The BLM will supply us with signs specifically encouraging visitors to be careful not to damage the environment. We will continue conversations with the City of Mesquite regarding providing OHV staging areas. The Kokopelli ATV Club and the clubs in Las Vegas and Logandale are volunteering the services of their members to help with sign installation as a project donation. The Nevada Conservation Corps will provide labor at a discounted rate as an in-kind contribution.

10. **Partnering:** Please describe coordination that has occurred with stakeholders, partners, and the public in which all interests have had an opportunity to be heard related directly to this project.

The Kokopelli ATV Club is partnering with the BLM on this project. The Las Vegas Dunes and Trails ATV Club and Partners in Conservation of Logandale will be working cooperatively with us to install the signs for this project. We will be in contact with the Lincoln County Sheriff's Office Search and Rescue (SAR) group to get their input on our safety signs and get permission to list them as one of the sign sponsors.

We will also be partnering with the Great Basin Institute/Nevada Conservation Corps to do significant amounts of this work especially in the hard-to-get-at areas between Caliente and Mesquite. They will provide us with younger laborers for sign installation at a significantly reduced hourly wage and per diem. They will also provide their vehicles and equipment and will camp out for three- or four-day periods in remote areas saving significant amounts of travel time and expense. The Kokopelli ATV club will provide overall supervision for their work and supply them with pre-labeled signs and some tools to help them with the installation. This partnership will assure that this project gets completed in as timely a manner as reasonably possible.

Further, we have engaged in dialogue and solicited letters of support from the City of Caliente, the City of Mesquite, and the Lincoln County Board of Commissioners. See attached.

11. **Youth and Family Engagement:** Please describe how your project helps to engage youth and families.

The FFA teacher at Mesquite High School, Terri Knight stated that this would be a good project for her students and believes that they would be very interested in participating. Soon after this grant is approved, we will be following up with her to make arrangements for her students to work with us.

12. **Economic Integration**: Please describe how your project develops outdoor recreation opportunities that help local and/or regional economies grow (e.g., economic impact, additional OHV funding sources, improved user, or business group participation).

We strongly believe that marking these roads and trails between Mesquite, Nevada and Caliente, Nevada and ultimately mapping it will provide recreational opportunities for the public (non-locals) who currently would not venture into these vast, unmarked areas for fear of getting lost, seriously injured, or worse.

14. **Maintenance:** Although this OHV grant requires maintenance of all facilities funded for 25 years or the normal life of the project, we would like you to please describe **how** the project will be maintained and **who** has committed to the ongoing maintenance of the facility or continuation of the service/project.

The Kokopelli ATV club in partnership with the Caliente BLM office is committed to the ongoing maintenance of these signs after this grant. We have purchased approximately 5 to 10% more signs than believed necessary to use for replacement due to vandalism or future loss. If for some unforeseen reason the Kokopelli Club cannot continue this maintenance, all materials and supplies will be given to the BLM office in Caliente. Besides maintaining the signs, we plan to follow this grant with another for the placement of trail marking and informational signage in Clark County and in Lincoln County to provide connectivity with the cities of Panaca, Pioche, and other state parks such as Beaver Dam State Park, Cathedral Gorge State Park, Echo Canyon State Park, etc.

Description of Proposed Action:

The goal for this project is to install road and trail marking signs in South East Lincoln County between Mesquite and Caliente, Nevada, which will clarify route connectivity between these two cities for OHV and other vehicles. Between 114 and 152 signs would be placed at 38 locations in desert tortoise habitat, but the overall project will include another 500 to 600 signs north of this habitat area on roads and trails between Mesquite and Caliente, Nevada. The purposes for the signs are to facilitate safe travel (minimizing potential safety issues for lost people) and protecting sensitive habitat by encouraging travelers to stay on marked roads and trails. This is the first phase of a project that will eventually include signs that highlight points of interest and other routes between Mesquite and Caliente. The principal source of volunteers will be the Kokopelli ATV Club with support from other interested volunteer groups throughout the region. Numerous other groups have volunteered to help us in this effort, and they will be welcome. All sign placement will be supervised by Trail Bosses from the Kokopelli ATV Club.

The Carsonite-type signs will meet the BLM/Lincoln County requirements for sign color and lettering/numbering for road or trail designation. These signs have a width of approximately 5 to 6 inches with only a 1/8 inch thickness. The signs will be placed at intersections on the right-of-way for roads and trails or as close as possible to prevent damage by road maintenance equipment. They will be installed using hand equipment purchased from the sign suppliers. Because of the difficult access from Mesquite, we plan to use UTVs and ATVs (rather than pickup trucks) possibly pulling a small ATV trailer carrying signs, supplies, and tools. While it is difficult to estimate the amount of manpower and/or vehicles needed to place the signs throughout Southeastern Lincoln County, we will only stop at each intersection once to place 3 to 4 road/trail marking signs barring unanticipated difficulties. Weather and worker availability will determine the time of year for signs to be installed. Since many of our Kokopelli ATV members in Mesquite, Nevada are "snowbirds", our Club's largest workforce is from October through April. Months when temperatures exceeds 90° (particularly in Southeast Lincoln County at its relatively low altitude) will be avoid for the safety of our volunteers.

It is my decision to approve the sign maintenance and implement the Kokopelli ATV Club's proposal as described below and as documented in the attached *Documentation of Categorical Exclusion of Federal Action* (CX) associated with the proposal.

Background Information:

The goal for this project is to install road and trail marking signs in South East Lincoln County between Mesquite and Caliente, Nevada, which will clarify route connectivity between these two cities for OHV and other vehicles. Between 114 and 152 signs would be placed at 38 locations in desert tortoise habitat, but the overall project will include another 500 to 600 signs north of this habitat area on roads and trails between Mesquite and Caliente, Nevada. The purposes for the signs are to facilitate safe travel (minimizing potential safety issues for lost people) and protecting sensitive habitat by encouraging travelers to stay on marked roads and trails. This is the first phase of a project that will eventually include signs that highlight points of interest and other routes between Mesquite and Caliente. The principal source of volunteers will be the Kokopelli ATV Club with support from other interested volunteer groups throughout the region. Numerous other groups have volunteered to help us in this effort, and they will be welcome. All sign placement will be supervised by Trail Bosses from the Kokopelli ATV Club.

The Carsonite-type signs will meet the BLM/Lincoln County requirements for sign color and lettering/numbering for road or trail designation. These signs have a width of approximately 5 to 6 inches with only a 1/8 inch thickness. The signs will be placed at intersections on the right-of-way for roads and trails or as close as possible to prevent damage by road maintenance equipment. They will be installed using hand equipment purchased from the sign suppliers. Because of the difficult access from Mesquite, we plan to use UTVs and ATVs (rather than pickup trucks) possibly pulling a small ATV trailer carrying signs, supplies, and tools. While it is difficult to estimate the amount of manpower and/or vehicles needed to place the signs throughout Southeastern Lincoln County, we will only stop at each intersection once to place 3 to 4 road/trail marking signs barring unanticipated difficulties. Weather and worker availability will determine the time of year for signs to be installed. Since many of our Kokopelli ATV members in Mesquite, Nevada are "snowbirds", our Club's largest workforce is from October through

April. Months when temperatures exceeds 90° (particularly in Southeast Lincoln County at its relatively low altitude) will be avoid for the safety of our volunteers.

Scoping and Public Involvement:

An Interdisciplinary team from the Caliente Field Office reviewed the proposed action from June 1 to June 20, 2017. Team members determined that this categorical exclusion is appropriate in this situation because there are no extraordinary circumstances potentially having effects that may significantly affect the environment. Documentation relating to this review is contained in the attached CX.

Rationale for Decision:

As determined on the associated *Documentation of Land Use Plan Conformance and Non-statutory Categorical Exclusion of Federal Action*, the proposed action is in conformance with the Ely District Record of Decision and Approved Resource Management Plan (August 20, 2008). The Proposed Action has been reviewed by BLM resource specialists and no further environmental analysis is required as none of the extraordinary circumstances described in 43 CFR 46.215 apply.

Appeal:

This decision may be appealed to the Interior Board of Land Appeals (Board), U. S. Department of the Interior (DOI) Office of Hearings and Appeals, in accordance with the regulations contained in 43 CFR, Part 4. The appellant has the burden of showing that the decision appealed from is in error. If an appeal is taken, a notice of appeal must be filed at the Bureau of Land Management, Caliente Field Office, 1400 S Front St., Caliente, NV within 30 days of either of receipt of the decision if served a copy of the document, or otherwise within 30 days of the date of the decision. If sent by United States Postal Service, the notice of appeal must be sent to the following address:

The appeal may include a statement of reasons at the time the notice of appeal is filed, or the statement of reasons may be filed within 30 days of filing this appeal. At the same time, the original documents are filed with this office, copies of the notice of appeal, statement of reasons, and all supporting documentation also must be sent to each party named in this decision and to the U. S. Department of Interior (DOI) Solicitor at the following address:

If a statement of reasons is filed separately from the notice of appeal, it also must be sent to the following location within 30 days after the notice of appeal was filed:

Quincy Street, Suite 300 Arlington, VA 22203 This decision will remain in effect during the appeal unless a petition for stay is granted. If the appellant wishes to file a petition pursuant to regulations at 43 CFR 2931.8 (b) 4.21 for a stay of the effectiveness of this decision during the time that the appeal is being reviewed by the Board, the petition for a stay must accompany the notice of appeal. A petition for a stay is required to show sufficient justification based on the standards listed below. If the appellant requests a stay, the appellant has the burden of proof to demonstrate that a stay should be granted.

Standards for Obtaining a Stay

Except as otherwise provided by law or by other pertinent regulation, a petition for a stay of a decision pending appeal shall show sufficient justification based on the following standards:

- (1) The relative harm to the parties if the stay is granted or denied,
- (2) The likelihood of the appellant's success on the merits,
- (3) The likelihood of immediate and irreparable harm if the stay is not granted, and

(4) Whether the public interest favors granting the stay.





We know this area well and there are hundreds of roads with nary a sign to be seen. Growing up in this area, all of us at PIC have learned the various roads and destinations through the years, but folks that move into this area or visit it are overwhelmed by the sheer number of roads and especially by the fact that many roads intersect and criss-cross each other through Beaver Dam Wash, Tule Desert, East Mormon Mountains, around Lime Mountain, and up, over and across Clover Mountain. A life-time of traveling and camping around Sam's Camp and my husband and I can still take the wrong road and have to backtrack—it is amazing that more people do not get seriously lost over the years.

The Mesquite ATV Club has been talking about installing directional signs on these roads for a while and with Stan Hargar taking the lead, they are now ready to submit a grant request to fund this effort. 
