

This request is for the purchase of one cattle guard, for the Pahrump to Tonopah trail where it crosses US-95 in Amargosa Valley. This project is primarily funded by the Recreational trails program, and was initially granted in 2019 for 2020 administration. However with the onset of covid, material shortages, supply chain issues, the price of the materials more than doubled. Nye county was able to have a revision to their RTP grant to cover some of the cost. However the complete material acquisition remains unfulfilled.

Specifically, the funding of the second cattle guard remains unsatisfied due to the more than doubling of the material cost.

This is an important feature on the Pahrump to Tonopah trail where it crosses US 95, as groups of OHV users bunch up on the shoulder of the highway to open and then close the gates creating an obvious hazard to both the automobile / truck traffic as well as that collection of recreational users.

Additionally those who do not close the gate create a hazard from grazing livestock gaining access to US95. Access that livestock entering the highway with the potential for catastrophic

result.

Replace existing gates in NDOT ROW boundary fence with cattleguards. Reinstall gate next to
cattleguard.

(1)so riders/drivers don't have to stop to open and close the gates,
(2) eliminate chance of gates being left open.



Grants will be scored based on answers to the Ten (10) criteria listed below. Each criteria carries a weight determined by the OHV Commission, voted upon during the public meeting on 9/7/2021. Please reference scoring criteria form.

- 1. Law Enforcement Strategy that addresses registration enforcement, including Public Education & Outreach aimed at increasing renewals and new registrations: *N*/*A*
- 2. Enhancement or Maintenance of existing trails and facilities: Cattle guards are one of the best items to include on any trail improvement. They add a level of safety that is far superior to any other induvial infrastructure improvement. This benefits both the OHV user, as well as the ranchers, and promoted unity among users of Nevada's public lands by removing a recurring point of contention between users.
- **3.** Training: *N/A*
- 4. Trail mapping and signing of existing trails and facilities: Cattle guards and road crossings are two features that provide a solid geo referenced point his also allows for a subsequent kiosk and mapping location.
- **5.** Connectivity/Loops: This cattle guard will be used on the Pahrump to Tonopah trai connecting the two largest communities in Nye County.
- 6. Planning, Environmental Studies, Conservation: this cttle guard minimizes the damage riders create by pulling off the trail, seeking alternative routes, to opening the gte, keep livestock and wildlife off the pavement.
- 7. Access: Closing of ranch gates is always a problem. Education to "leave them as you found them" is lost on my users, and this eliminates one opportunity for a failure to lead to a catastrophic accident. Allowing foe simple access to public lands and the users to this trail is the exact definition of "respected access is protected access"
- 8. Partnering and Leverage: Nye County is the project lead for installing these gates, they have partnered with BLM, and NDOT for access and permissions this grant is only for the purchase of the cattle guard.
- **9. Economic Integration:** This gate will be installed on the Pahrump to Tonopah trail. This trail is part of the Battleborn OHV trail that will be identified and launched in 2023. The trail connects Pahrump, Amargosa, Beatty, Gold Point, Goldfield, Mina Hawthorne, Yerington, Minden, Carson city and Virginia City.
